(57) **CLAIM**

The ornamental design for a wall planter, as shown and described.

DESCRIPTION

FIG. 1 is an enlarged front, left isometric view of a wall planter of my new design oriented vertically on the horizontal sheet to show the intended position of use;
FIG. 2 is an enlarged isometric view of the wall planter of FIG. 1 turned to show the top interior from the right;
FIG. 3 is an enlarged bottom, left isometric view, of the wall planter of FIG. 1;
FIG. 4 is a front elevation view of the wall planter of FIG. 1;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a left side elevation view thereof;
FIG. 7 is a right side elevation view thereof;
FIG. 8 is a top plan view thereof; and,
FIG. 9 is a bottom plan view thereof.
